ORDINANCE NO.: 90-2

AN ORDINANCE OF HERNANDO COUNTY PROVIDING FOR THE AMENDMENT OF SECTION 12-92 OF THE CODE OF ORDINANCES, HERNANDO COUNTY, FLORIDA; PERTAINING TO THE CHANGE OF EXHIBIT "A"; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ENACTED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:

SECTION I.

Hernando County Ordinance 89-25 was adopted through the use of an emergency enactment procedure as set out in Section 125.66(3), Florida Statutes.

SECTION II.

After due public notice, Ordinance 89-25 was reconsidered at a public hearing on January 23, 1990, at which no amendments to Ordinance 89-25 were proposed or adopted. Thus this ordinance ratifies Hernando County Ordinance 89-25.

SECTION III. INCLUSION IN THE CODE.

It is the intention of the Board of County Commissioners of Hernando county, Florida, and it is hereby provided, that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end, the sections of this ordinance may be renumbered or relettered to accomplish such intention, and that the word "ordinance" may be changed to "section", "article", or other appropriate designation.

SECTION IV. SEVERABILITY.

It is declared to be the intent of the Board of County Commissioners that if any section, subsection, clause, sentence phrase or provision of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this ordinance.

All of Township 22, Range 17, less that portion of section 36 contained within the Spring Hill Fire District.

All of Township 22, Range 18, less High Point Mobile Home Subdivision Units 1-6, and less that portion contained within the Spring Hill Fire District.

Sections 1, 2, 3, 4, 5, 6, East 1/2 of 9, 10 and 11 of Township 23, Range 17 less that portion contained within the Spring Hill Fire District.

Sections 1, 2, 3, 4, 10, 11 and 12 of Township 23, Range 18 less that portion within the Spring Hill Fire District.

All of Section 13, Township 22, Range 16.
